Highly Motivated Virginians Encouraged to Apply

Individuals who want to develop or strengthen their advocacy and leadership skills are encouraged to apply. Partners are chosen through a statewide competitive application process. If accepted, attendance is required at all seven training sessions beginning September 2025 and ending April 2026. There are no costs incurred by the applicant to participate in the program.

Eligibility

Residents of Virginia with developmental disabilities (DD), as defined by the Developmental Disabilities Act, and/or parents of young children with DD are eligible to apply for PIP.

Benefits

- Get connected, speak up, educate and communicate on inclusion, quality of education, accessible housing, and supported employment for people with DD.
- Build positive relationships with families, schools, employers, elected officials.
- Learn how to impact local, state, and national policies through advocacy and awareness.
- Improve the lives of people with DD in your local community and in VA.
- Understand the strategies used to support people with DD.

Monthly PIP Sessions begin on Fridays at 1 p.m. and conclude Saturdays at 3p.m. PIP Sessions will be held using the hybrid format (in-person and virtual).
